1. General presentation

The international conference “**Peace with Water**” is organised by the World Political Forum, based on a proposal by the European Research Institute on Water Policy (IERPE) (Belgium), and co-organized and/or with the participation of European deputies of the main Political Groups of the European Parliament and of the federal and regional authorities of Belgium.

“**Peace with water**” has two different meanings here:

- To stop all aggressions and predations targeted against water resources;
- To prevent and avoid conflicts surrounding propriety and access to water.

The problem of water has entered strongly at the top of the UN institutions' political agenda, particularly in connection with the world programme of strategies to mitigate and adapt to climate change.

“**Peace with water**” follows the objectives and overall spirit of the *World Water Assembly for Elected Representatives and Citizens (AMECE)*, held for the first time at the European Parliament (18-20 March 2007), and finds its roots in the frame of perspectives opened by the propositions and resolutions adopted by the conference «*From Global Warning to Global Policy*», organised by the *World Political Forum* in Turin (Italy) on 28 and 29 March 2008. These included priority actions that have to be taken to ensure effective political solutions are applied at a global level for the human, social, economic and technological challenges provoked by climate change.

The conference will be held on 12 and 13 February 2009 in Brussels, at the European Parliament. Participation is open to any person or organisation sharing the conference's objectives. It is however limited to 600 participants because of logistical constraints at the Parliament (number of seats, etc.), and the following categories of participants are invited as a priority:

- parliamentarians,
- local elected representatives and administrators
- governments and international/intergovernmental organisations
- public unions and other concerned unions (agricultural, industrial...)
- water companies
- representatives from the education, academic and research areas
- associations and movements of the civil society

The Conference has been launched on the initiative of a Committee composed of:

- **Mikhail Gorbachev**, President of *The World Political Forum* and of *Green Cross International*, two active organisations working on the prevention and resolution of water conflicts, Russia
- **Mario Soares**, former President of the Republic of Portugal and President of the International Committee for a World Water Contract, Portugal
- **Guy Laliberté**, Founder of the *Cirque du Soleil* and of the «*One Drop*» Foundation, Canada

2 . Objectives of “Peace with Water”

The main problems and issues of water, at the base of the current "**world water crisis**" are widely known. There are proposals and solutions elaborated at national and international levels, including United Nations bodies, and, recently, in the scenarios presented by the International Panel on Climate Change (IPCC). The question stems from the political weakness of a global capability to answer and act in terms of priority common objectives and international institutions equipped with adequate financial means. Today's world water crisis calls for a real "World Water Marshal plan".

The main objective of "Peace with Water" is to discuss and elaborate a **Memorandum for a World Water Protocol (M-WWP)**, based on the prevention of conflicts, the promotion of the right to water for all and the safeguard of the world water heritage for a responsible and effective management of water as a common good, also in the interest of all living species and of future generations (beyond a poorly defined anthropocentrism).

This does not involve taking the place of States. Through the elaboration of a Memorandum proposing the main outline of a World Water Protocol, "Peace with Water" aims at putting the water issue, as such, into the agenda of the 2010-2012 negotiations that will be approved at the Copenhagen conference in December 2009 (COP 15) in view of the new "Post-Kyoto" agreements.

At present, priorities of political agendas regarding environment and water are increasingly set up within the framework of the strategies of mitigation and adaptation to climate change. The spotlight is often placed on energy matters and on the price of CO2 consumption; this is a necessary and plausible answer to our dilemma, but insufficient. The success of the fight

against the warming of the atmosphere is achieved through complex solutions from different sectors (health, soil, agriculture, transports, migrations, social values...) and levels.

The Memorandum for a World Water Protocol (M-WWP) will be submitted to the attention of those in charge of the United Nations Framework Convention on Climatic Change (UNFCCC) on the occasion of Copenhagen 2009. It will be up to the negotiators of "post-Kyoto" to decide the appropriate follow up to the protocol. The promoters of M-WWP will try their best to get proposal considered.

If the water issue should not be included in the agenda of the post-Kyoto negotiators, two scenarios seem possible: we could witness the absence of a specific intergovernmental agreement about water at a global level (in this case, the water issue, as the one of food, will be treated only within the framework of the measures and instruments relevant for the energy matter); OR the public intergovernmental gap could be covered by a world regulation of water problems by actors from the water industry (in this case, the development of the universal right to life and the management of the planet's water resources will mainly be influenced by the needs and interests of the main industrial, commercial, energy and food groups of the world, as well as producers and consumers of water).

To better position the efforts of the conference on strictly scientific bases, certain processes of preparatory research have been elaborated, under the responsibility of IERPE, on the following subjects:

- A continent to free from thirst: sub-saharian Africa;
- The three main water-ill countries of the world for the next 30 years: The United States of America, India and China;
- The richest fresh water reservoirs of the world in the 21st century: Canada, the Latin-American continent and Russia;
- Central Asia and water: a region of demonstrative value
- Political and institutional engineering used to prevent and solve conflicts around water

Conference Programme

A . General Structure

The conference will be structured on four half-days:

- two half-days in plenary sessions (morning of 12 and afternoon of 13 February)
- two half-days in parallel sessions (afternoon of 12 and morning of 13 February)

It will be possible to participate at the plenary sessions in several languages: Spanish, German, French, Portuguese, English, Dutch, Italian and Russian.

The plenary session of the 12 February 2009 morning will handle the world water issue. It will be structured around four sections:

- **The politico-cultural message**, among others by the representatives of the institutions organizing the conference;
- **The scientific “message”**. **The knowledge at the base of “Peace with Water”**, by representatives of IERPE;
- **Water: visions and life of peoples**, by the “world witnesses” of the commitment for the right to water and water as a common good;
- **Reflections**: by the representatives from Belgium and the presidents of the political groups of the European Parliament

The project of a proposal for a World Water Protocol leads to the big themes of the water issue and to provide concrete answers to the world water crisis. It has also been considered advisable to divide the works of the parallel sessions into four themes:

<i>Session A - Water, a human right</i>	(12 February afternoon)
<i>Session B - Water, a common good</i>	(12 February afternoon)
<i>Session C - Water, a global resource at risk</i>	(13 February morning)
<i>Session D - Water, a source of peace</i>	(13 February morning)

The study and discussion of each block will be introduced by the session's Chairperson and will have a rapporteur.

The programme will include:

- 65 scheduled interventions for a total of 22 hours (1630 minutes on a total limit of 27 hours and 10 minutes);
- space/time for debate for a total of 5 hours and 10 minutes

Supposing that the average time of each spontaneous intervention will be of 7 minutes, we can imagine the participation of about 45 people at the debate and exchange of views.

The plenary session of 13 February afternoon will include three segments of mutual enrichment and sharing:

- the synthesis proposed by the four rapporteurs of the parallel sessions
- two attempts at "preliminary conclusions" (one on the individual issues at stake and relevant answers; the other on the juridical-institutional orientations for the Memorandum)
- the opening of action paths for the water issue by the "creators", "innovators" and "project bearers"
